Requested undergrounding presentation regarding the Shores completion

Even though construction is going on at the UCSD site, the CEQA lawsuit is alive and well. We appreciate the public's continuing support on this matter, including over \$22K in donations.

Secretary's Report – Charlie reported attendance record of Directors is good at this time. However, he has noticed some people have not been attending full meetings. Heavy water activities. 4th busy, but cleared early. Cliff rescues slower.

President mentioned that a person reported to her that large busses of people with surfboards have been seen unloading at Kellogg Park. They wondered if this was legitimate. McBride responded that there have been non-profits working that don't have to go through the normal RFP process.

SDG&E Undergrounding on Via Capri & La Jolla Scenic North - B. Butkiewicz

SDGE will be replacing high voltage supply lines from the Rose Canyon substation near Gilman Court down to a substation at Eads Ave and Pearl St. This will involve replacing and upgrading buried conduit from Rose Canyon to Mount Soledad, and replacing cable only from Mount Soledad to Eads Ave. Work will start in the fall with completion by fall of 2022.

PARC Plan Issues and Scope - D. Kane

Update on the impact of the City Parks Plan on the Shores

The fourth draft of San Diego's Parks Master Plan may impact funding for La Jolla parks.

This is because the plan provides most of the funding to park-deficient communities. La Jolla receives almost no development impact fees.

Shores Traffic Committee Report - S. Wiczynski

Meeting with city determined crosswalk could be added at La Jolla Shores Dr and Vallecitos if pedestrian activated flashing light was added as well as streetlight. Also long-term possibility of roundabout. There are already approved plans for a crosswalk, streetlight and pedestrian activated flashing light at La Jolla Shores Dr and Camino del Collado.

MOTION: Install crosswalk striping and pedestrian activated crosswalk light at the corner of La Jolla Shores Drive and Vallecitos. Request the City to investigate a roundabout at this location with the intention of installing a roundabout there.
