Reports:

Beach Fires report – Andi Andreae

Amendment to the Municipal Code regarding beach bonfires fires to limit wood fires to City provided rings only and all other fires are propane only. This was approved in its second reading. It will go into effect 30 days after Mayor signs. Dorie DeFranco looking forward to enforcement and reduced pollution. Brian suggested appropriate signage should be implemented.

Will have additional Sargent working at night starting 1/23/23. Lifeguards are on call 24/7.

Use extreme caution under the current conditions. Again, emphasized that experts only in ocean, and only near lifeguards.

CAF Community Challenge - Kristina Entwistle (ACTION ITEM)

Wanted to have the San Diego Triathlon Challenge at Kellogg Park in The Shores. But doesn't look like it will be a good fit due to space & parking requirements, 4 day duration, amplified sound requirements and hotel room availability. So instead, they would like to hold just the finish of the Million Dollar Challenge 620 mile bike ride down the coast of California at La Jolla Shores Kellogg Park north end. This has been done in this manner for the past 16 years.

Discussion ensued as to exact rules that their requirements wouldn't meet. Suggestions were offered including using SIO if possible. Will revisit when get more information.

MOTION: Approve CAF's use of North end of Kellogg Park on October 20th, 2023, for the end of the Million Dollar ride celebration and picnic.

The President pointed out that our job as a Park and Rec Council for the City is to bring up these issues so that events are appropriately scheduled around the peak times in the beach area. Also, that the people using the park, which is a public park, have the ability to do that. So that is our job.

Ragnar Relay SoCal 2023 - Katie Cordova (ACTION ITEM)

Ragnar Relay SoCal would like to include Kellogg Park as a checkpoint for their relay run in April. Would need to block off 93 spaces in parking lot for 7 hours on a Friday afternoon during Spring Break.

Discussion ensued regarding private use of so many spaces on busy weekend. And possible use of SIO.

MOTION: Approve Ragnar Relay's use of Boardwalk for their run, but not use of Kellogg Park as an Exchange nor blocking of parking spaces.
